1. The Waling Municipality Office, Syangja invites sealed bids from registered bidders for Construction of Khahare community building works at waling -8 and Urban Health clinic building Works at Waling 5.
2. Detail of Qualification requirements including minimum required average annual turnover, experience in similar nature of works, minimum no. of essential equipment, qualification and experience of key site manager and technical personnel, minimum of liquid assets and/or credit facilities as specified in bidding document.
4. A complete set of bidding documents may be purchased by the interested bidders upon submission of a written application to the office of Waling municipality, Syangja and upon payment of a non-refundable fee or its equivalent in freely convertible currency as shown in the below table. Bidding documents can be purchased within the office hrs 12:00 up to 2072/12/04.

For the purpose of Bidders who choose to submit their bid electronically can submit their bids at E-procurement Website of PPMO, <http://www.bolpatra.gov.np>, the Bidders may either purchase the hard copy of bidding documents or may choose to download the necessary part of bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. In case the Bidder chooses to download and submit bid electronically, the Bidder shall be required to deposit the cost of bidding document (as specified in the below table) in the Municipality revenue account either by direct deposit or by tele-transfer of deposit in the Municipality account for the purchase the bids as specified below and electronic scanned copy (PDF format) of the Bank deposit voucher or Tele-transfer certificate shall also be submitted along with the electronic bid files.

5. Bids must be delivered to the office of Waling Municipality, Syangja on or before 12:00 hrs of 2072/12/05. Alternatively, bidders may submit their bid electronically through E-procurement website of PPMO's Web Site <http://www.bolpatra.gov.np> as specified in the Instruction to Bidders. Documents received after deadline shall not be accepted. Bids will be opened physically and electronically immediately after the bid submissions deadline in the presence of the bidders' representatives who choose to attend in person at Municipality Office, Syangja.

7. All bids shall be accompanied by a valid bid security of an amount as shown in the below table. The bid security guarantee shall confirm to the standard format as specified in the bid document. The bid security guarantee issued by only the commercial bank approved by Nepal Rastra Bank shall be accepted by the employer.

8. Bids shall be valid for a period of 90 days after the deadline for bid submission date. Bid security shall remain valid up to 120 days.

9. Pre-bid meeting will be held in the office of Waling Municipality Syangja at 13:00. hrs on 2072/11/20. Detail Information about submission process of bid electronically (e-submission) shall be provided to all interested bidders who choose to attend this pre-bid meeting.

10. If the specified date for pre-bid meeting, last date of bid document purchasing and submission/ opening falls on a Government holiday then the same time on the next working day shall be considered for such events. However, the last date for bid submission and opening shall be the next working day after the last date of bid purchasing. In such case the validity of bid security shall be considered from already specified last date for bid submission.

11. Any matters, not covered here shall be as per prevailing rules and regulations of Nepal. The **waling Municipality, Syangja**, reserves right to accept or reject wholly or partly any or all the bids without assigning any reason, whatsoever.
